**Town Board Meeting Minutes**  
**Monday, October 7, 2024 7:00PM**

Call To Order-Chairman Gunn called the monthly Town Board meeting to order with all Board members were present.

Approval of Minutes-Supervisor Parker moved to approve the minutes for September 3 and September 26 as presented. Second by Supervisor Dubanowich. Motion carried with a voice vote.

Treasurer Report- Supervisor Parker moved to approve the treasurer's report as presented. Second by Supervisor Dubanowich. Motion with a voice vote.

Zoning Report-There was no zoning report-Dave Diestler was absent.

Planning and Zoning-Supervisor Dubanowich reported some residents inquired about permits for garages.

Audience Communication-Dan Jones questioned the large trucks on Bakke Road, the Board wasn't sure of their business-possible fiber optic installation. Bruce Danielson, candidate for Wisconsin Assembly District 44 gave a bio for his campaign.

Review and Possible Action on Ordinance Violation at Storage Containers at 3317 South Oakhill Avenue, Janesville-Resident was present regarding the storage containers. He stated he had the permits to move forward with building a permanent unit. He wasn't aware of correspondence Attorney Lindau had sent to the listed registered agent, Mark Robinson regarding a deadline of October 7 to have the containers removed. Supervisor Parker moved to incur a \$500 fine due now and after November 1 there will be a \$100 per day forfeiture until the storage containers are removed from the parcel. Second by Supervisor Dubanowich. Motion carried with a voice vote.

Review and Possible Action on the Proposed Allocation of ARPA Funds-Supervisor Parker moved to approve \$13,000 for fencing for Pickleball Court, \$2000 for landscaping around the Pickleball Court, \$22,500 for Town Hall roof replacement, \$17,000 for soundproofing in the Town Hall, \$7500 for trees at the Park and Cemetery and \$6200 for Electrical work using ARPA funds and/or ATC funds. Second by Supervisor Dubanowich. Motion carried with a voice vote.

Approve Operator Licenses-Supervisor Parker moved to approve operator licenses for Scott Weaver, Marc Mellott, Ashley Gaona, Stephanie Najera, Cierra O'Dowd, Tanja Brosier, Devin Madonna and Bernadin Watters. Second by Supervisor Dubanowich. Motion carried with a voice vote.

Bills-Supervisor Parker moved to approve payment of the invoices as presented. Second by Supervisor Dubanowich. Motion carried with a voice vote.

Adjournment-Supervisor Parker moved to adjourn. Second by Supervisor Dubanowich. Motion carried with a voice vote.
