On behalf of the town of Rock board, I would like to bring you up to date on the year's activities in the township. The board remains the same as I continue to act as your Town Chairman together with Tony Dubanowich and Pete Parker as Supervisors. Judy Thostenson remains the Constable. Kristina Bennett has been hired as the Clerk/Treasurer and acts as the recycling coordinator and handles the Rock Town Cemetery. Deb Bennett acts as our Deputy Clerk/Treasurer.

There is a new sign at the Town Park through a donation from the Polzin Family at Budget Truck and Auto, Inc.

The Town will again host two e-waste pickups with the coordination of Waste Management. The pickups will be at Waste Management's location on Townline Road on April 22, 2023, and on September 16, 2023. As in the past, a notice will be mailed to each resident.

The road projects in 2022 included paving Ehrlinger Road, grader patched South River Road from County D to the Highway 11 Bypass intersection, grader patched corner of Tracey and Eau Claire Road and crack-filled O'Leary Road. We applied for funds at the state level for the federal infrastructure bill but were not chosen to receive the funds.

Thank you to the poll workers for offering their services in the election this year. We had a large turnout for the fall election, and we could not do it without the workers' willingness to serve.

Remember to use the Afton Post Office when mailing your packages. The walk-up window is open in the afternoons.

Dogs that are more than 5 months of age are required to be licensed (Wis. Statute 174.05). To apply for a license, send the required information with your payment to the Town of Rock, Po Box 25, Afton, WI 53501. When applying for a dog license, include the owner's name, address, and phone number, as well as the dog's name, age, breed, color, and proof of alteration. A copy of the certificate of rabies must accompany your application. Fees: \$5.00/ altered dog, \$10.00/unaltered, \$5.00/puppy. To ensure all of the necessary information is included, the official Dog License Application can be obtained on the Town's website. Applications made after March 31, 2023 will incur a late fee of \$5.00.
